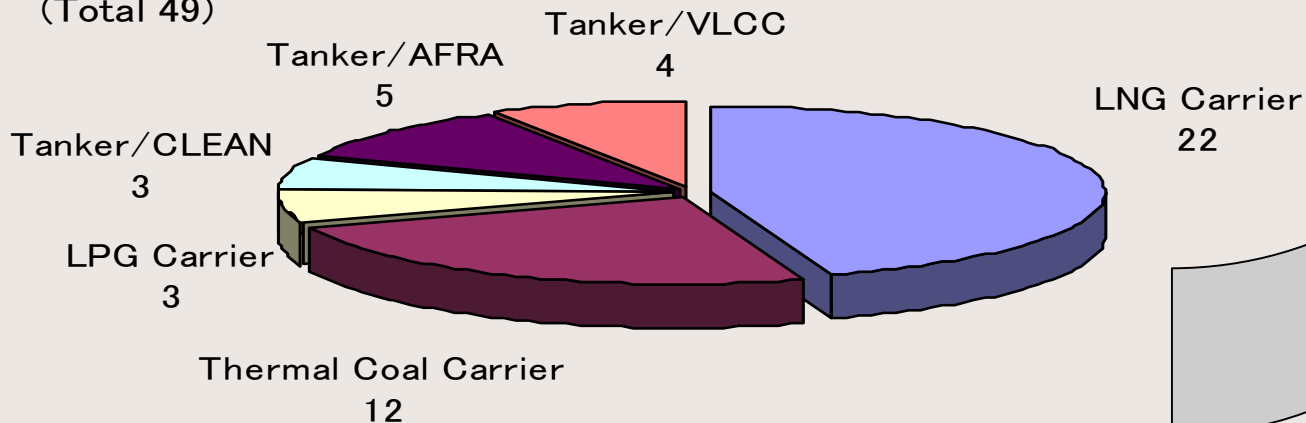

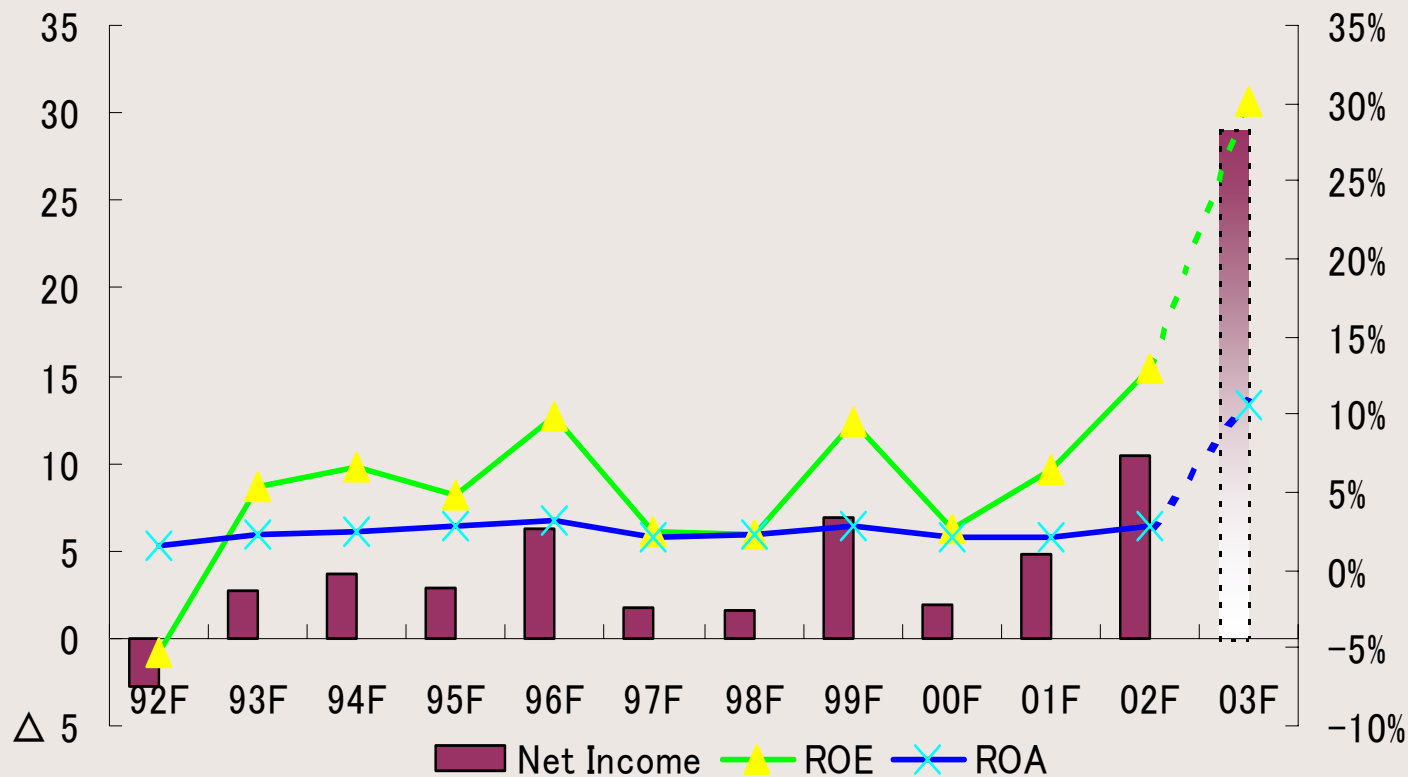

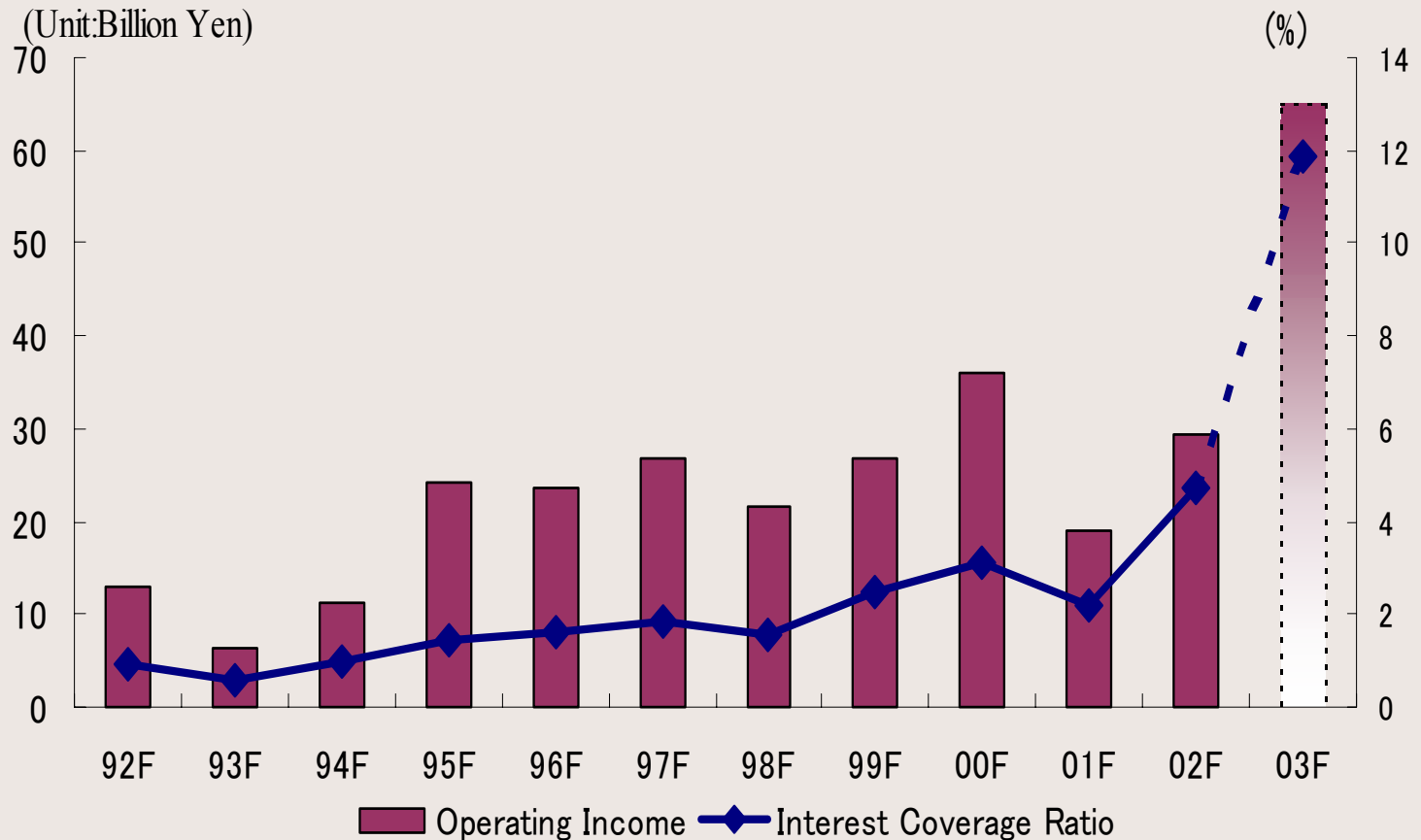

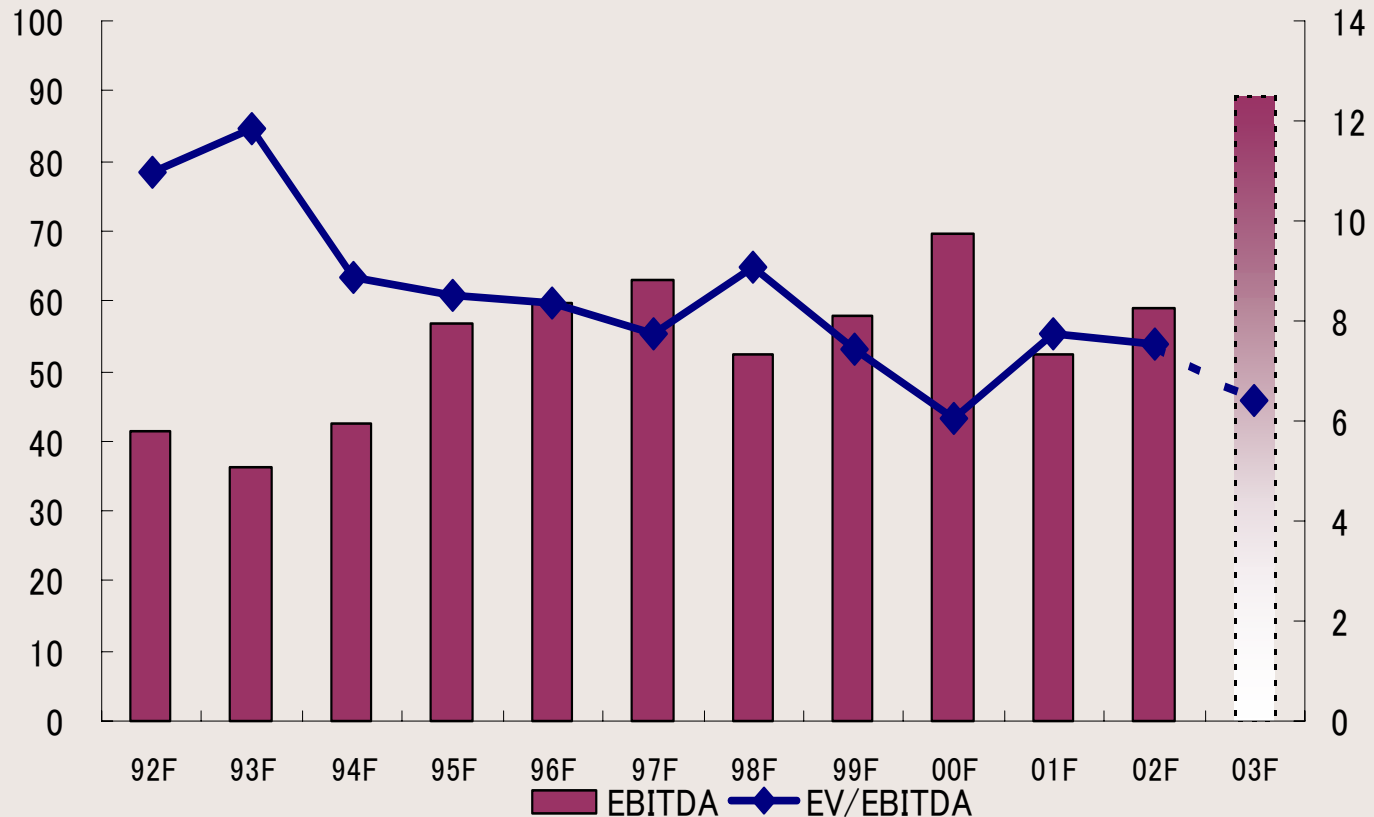


2-3. Consolidated Interest Coverage Ratio



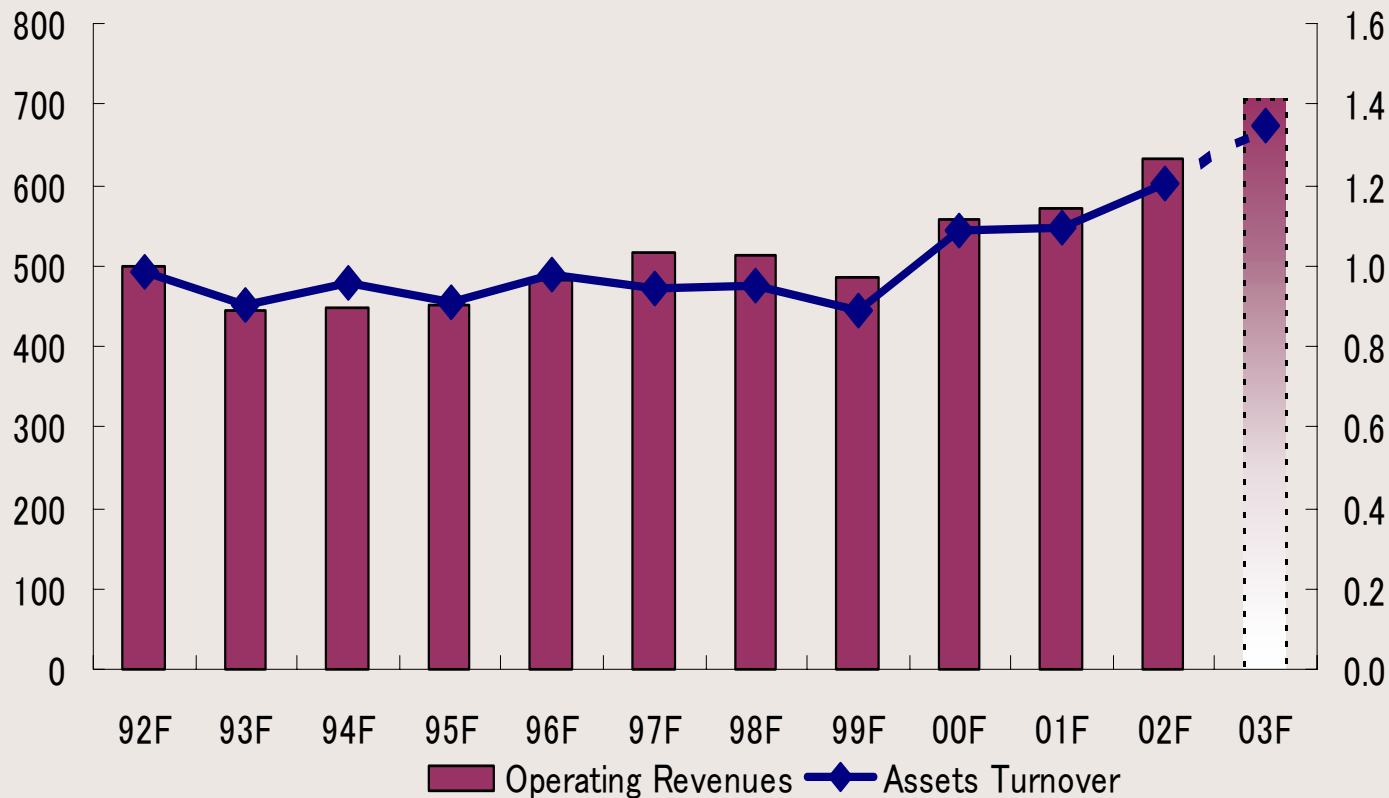
2-4. Consolidated EV/EBITDA

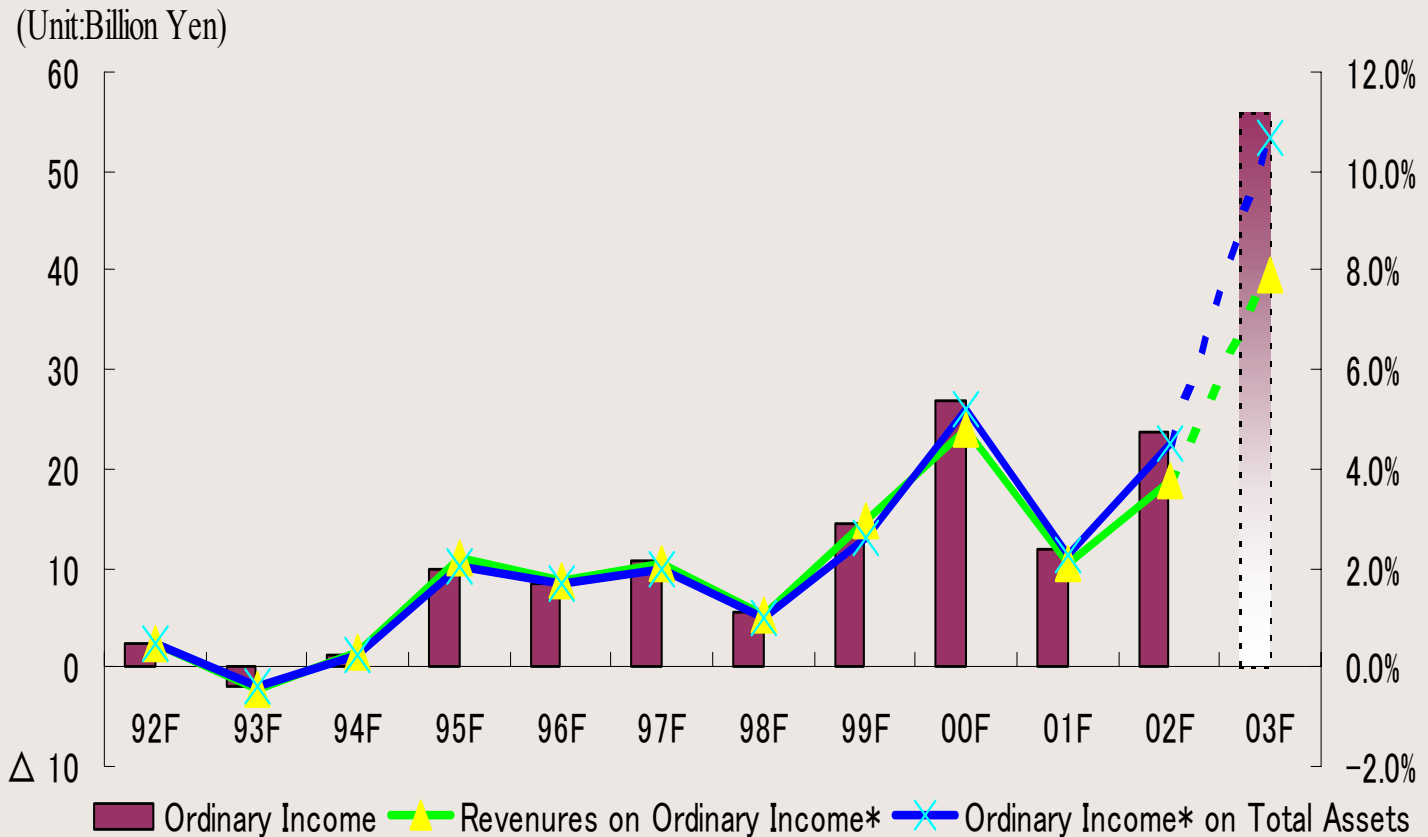


2-5. Consolidated Assets Turnover

2-6. Consolidated Ordinary Income* on Revenues/ Ordinary Income on Total Assets

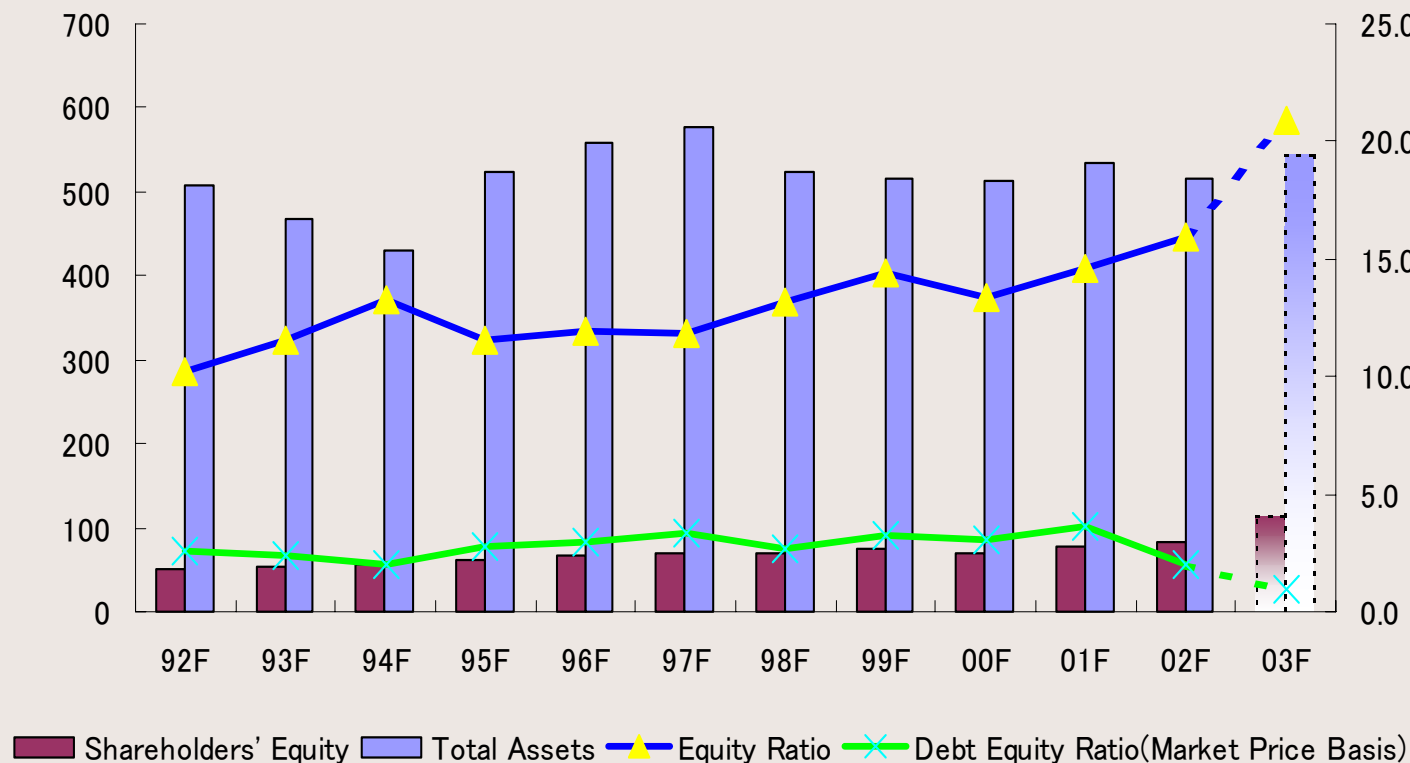

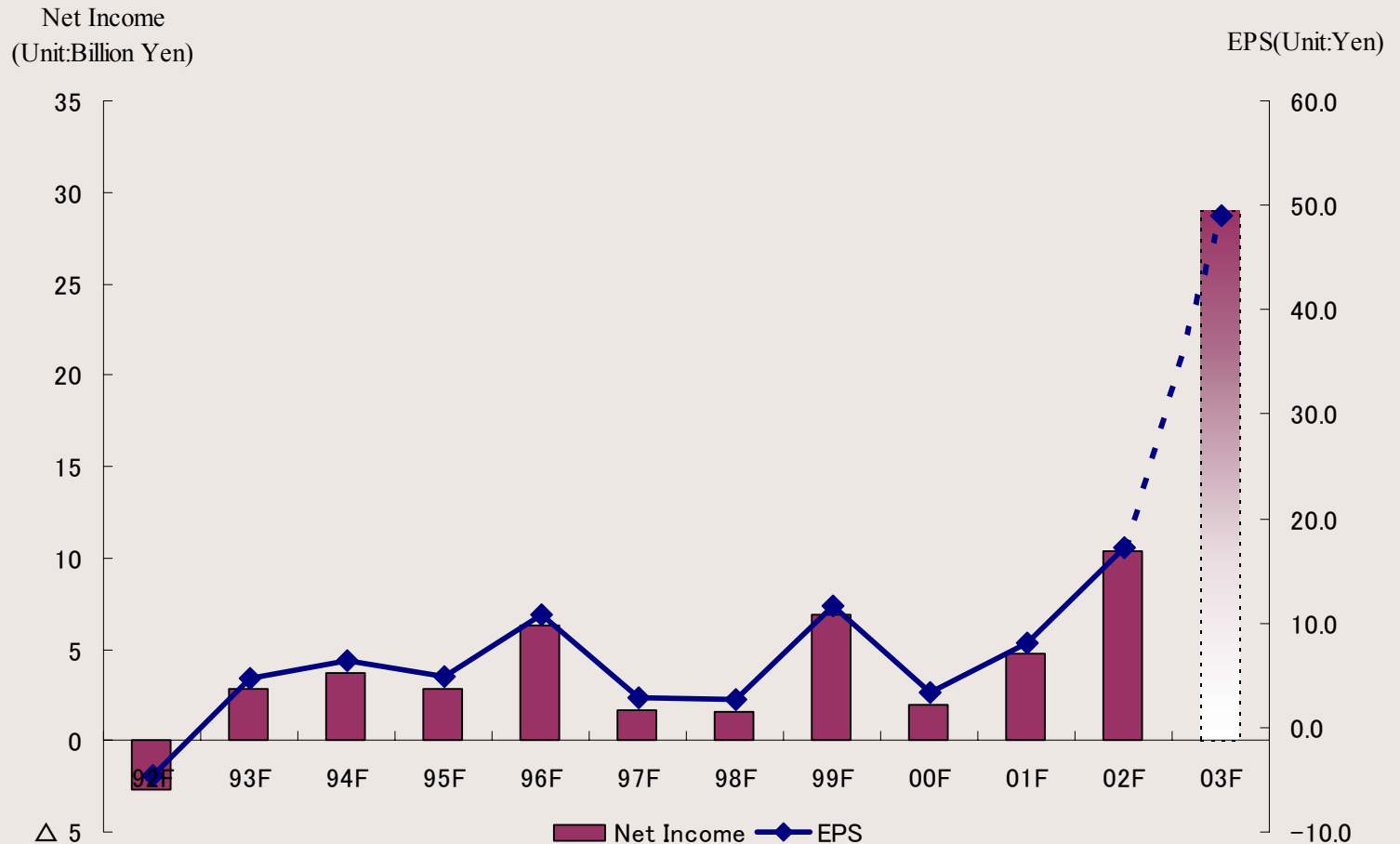
2-7. Consolidated Equity Ratio & Debt Equity Ratio

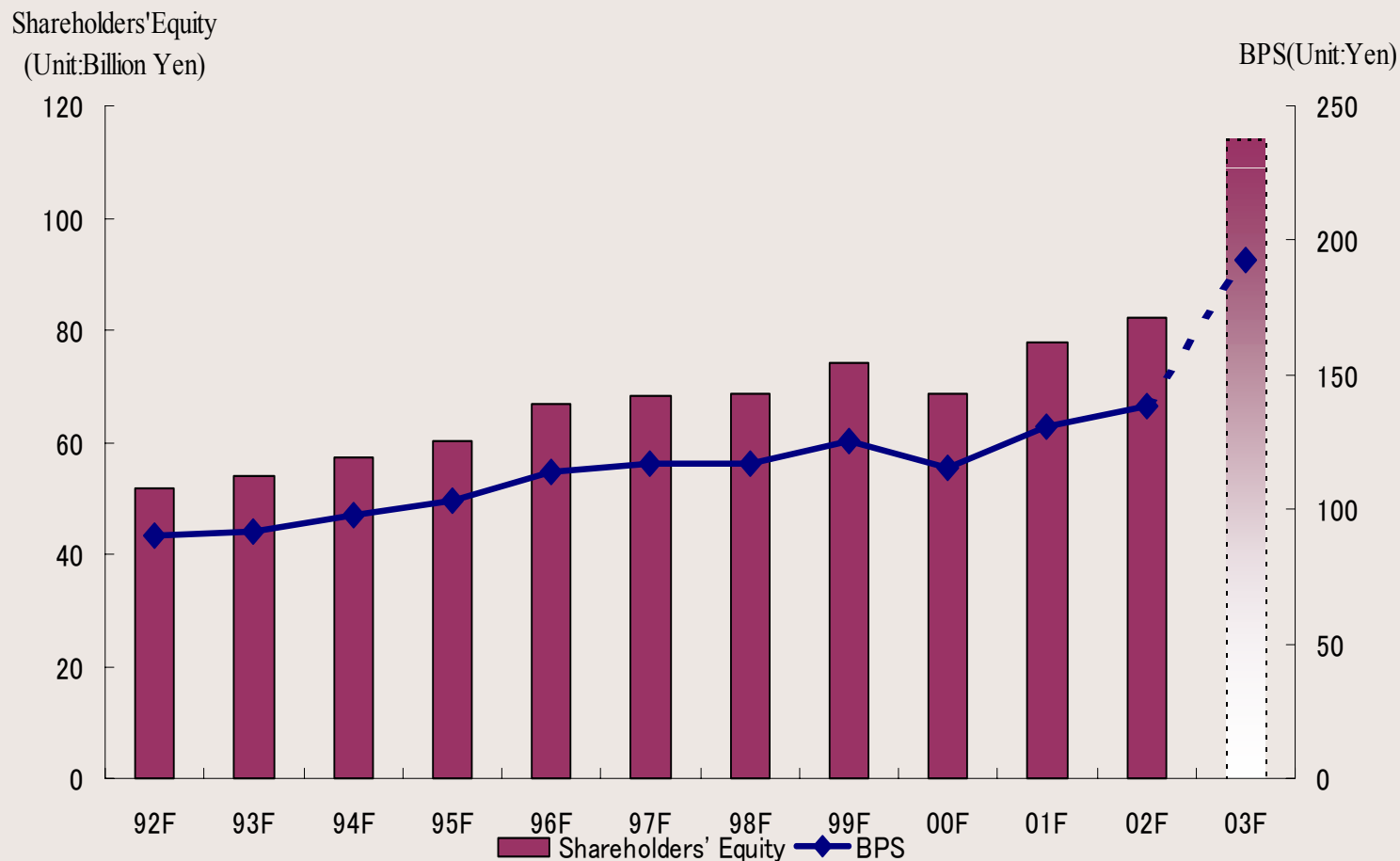

2-8. Consolidated Net Income & EPS



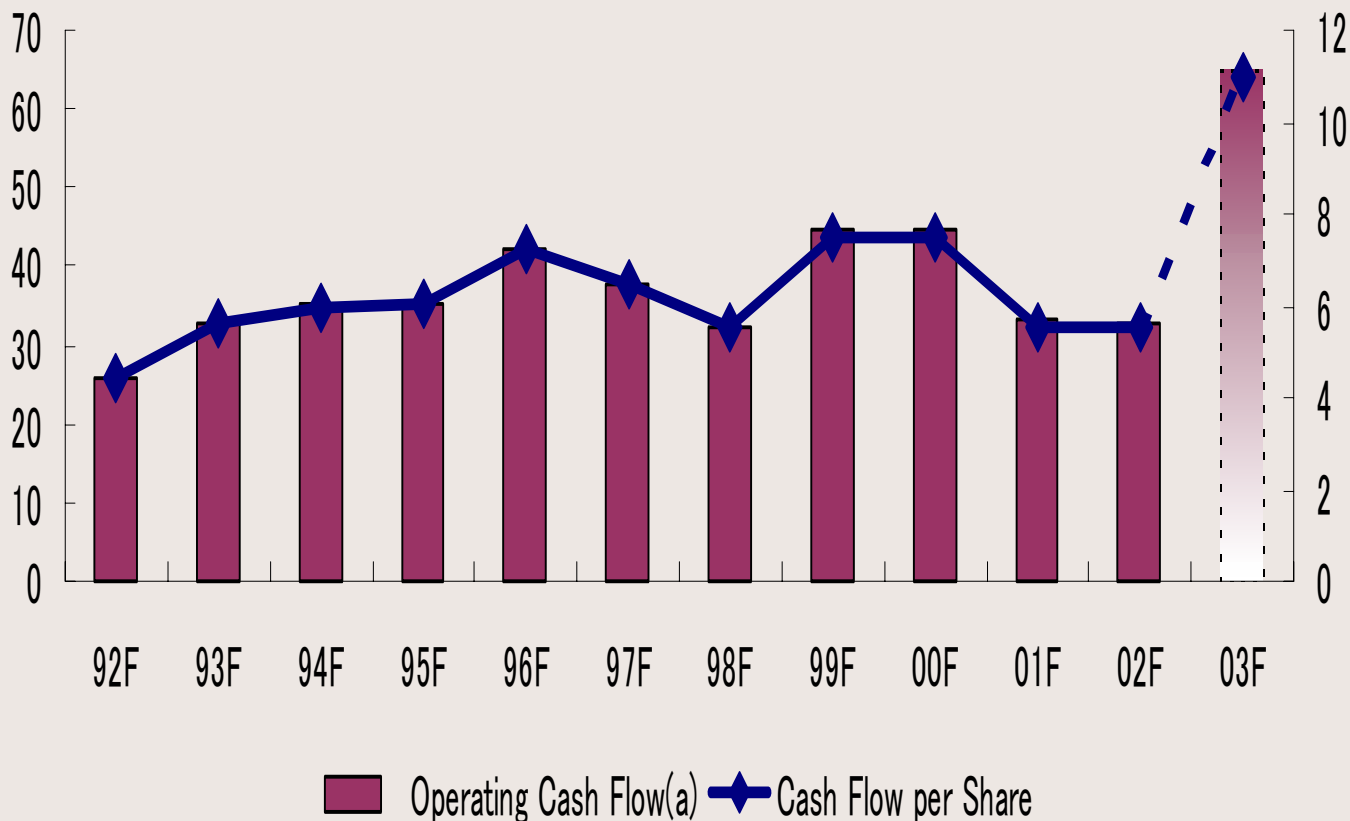

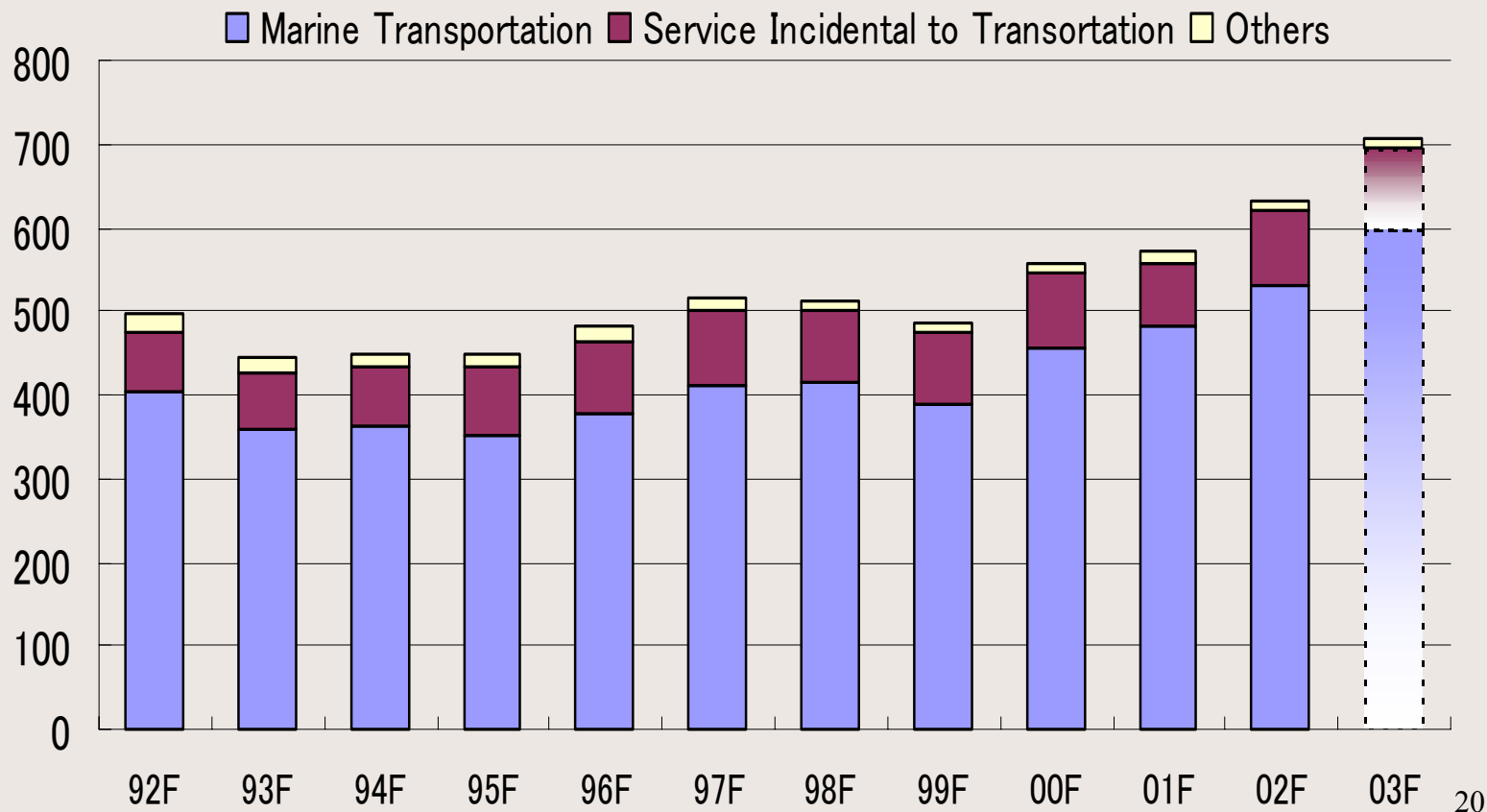

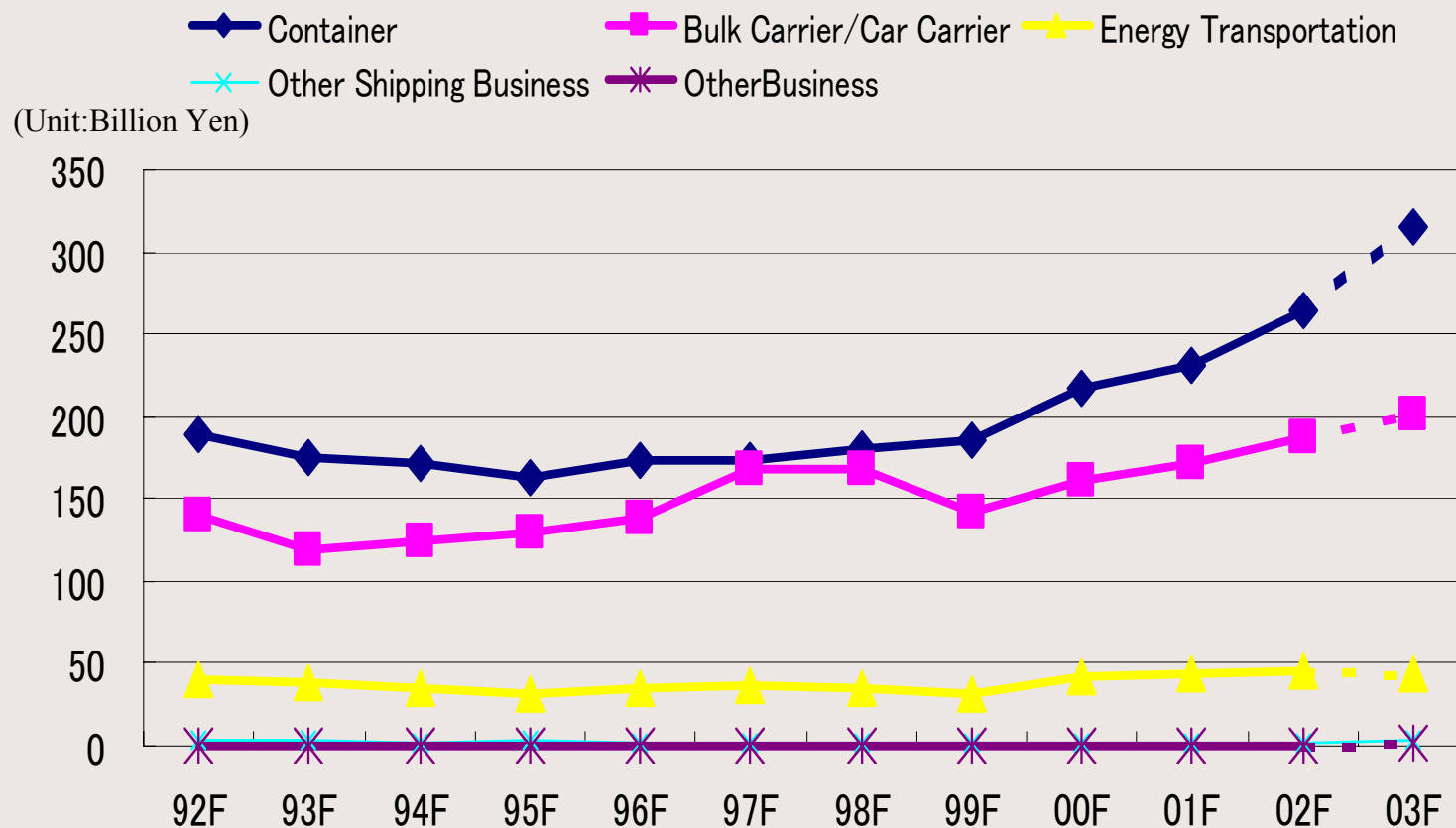


2-11. Consolidated Segment-wise Operating Revenues
