## Notification of the Continuous Selection as a Constituent of the "JPX-Nikkei Index 400"

Kawasaki Kisen Kaisha, Ltd. ("K" LINE) announces that it has been continuously selected as a constituent stock of "JPX-Nikkei Index 400" in FY2025 (from August 29, 2025 through August 28, 2026), which are stock price indices calculated jointly by JPX Market Innovation & Research, Inc. and Nikkei Inc.

The JPX-Nikkei Index 400 is composed of companies with high appeal for investors, which meet requirements of global investment standards, such as efficient use of capital and investor-focused management perspectives.
